TERMS OF SERVICE

- **WARRANTY:** Urgency of the work will dictate the urgency of the service time frame. Parts and labor of warranty work is subject to manufacturers claim approval(s). The owner is responsible for parts, labor and transportation costs if the claim is declined.
- **NOT COVERED:** Parts, labor and transportation for boat damages are the responsibility of the boat owner. Summerizations, annual maintenance, winterizations, and storage are not included.
- **CONTRACT:** Boat Owners must sign a contract agreeing to the terms of the *PLUS Program* to qualify for benefits prior to requesting service. When requesting a service, you must mention you are a *PLUS Program* member.
- **DATES:** The *PLUS Program* is good for the summer - from delivery to Labor Day.
- **TRAVEL:** Pick-Up & Delivery includes the first 50 miles using one driver. Additional mileage and labor will be charged.
